5. **MONITRO RISG**

Cafodd asesiad o'r risgiau sy'n gysylltiedig â Chronfa Bensiwn Rhondda Cynon Taf, a'r mesurau rheoli sydd mewn grym, eu cyflwyno i'r Bwrdd.

Gofynnodd y Bwrdd am ystyried cynnwys yr ymosodiad seiber diweddar yn risgiau'r Gronfa Bensiwn. Cadarnhaodd Pennaeth Pensiynau, Cyflogres a Thaliadau – ar ôl cael eglurhad gan Adran Technoleg Gwybodaeth a Chyfathrebu y Cyngor – fod y risg benodol yma yn rhan o gofrestr risgiau Cyngor Rhondda Cynon Taf a'r Bwrdd Rheoli Gwybodaeth. Mae diogelwch data a system y Gronfa Bensiwn yn cael ei gynnal yn rhan o seilwaith Technoleg Gwybodaeth a Chyfathrebu y Cyngor ei hun, ac yn destun dulliau rheoli perthnasol.

O ran CBRE yn torri terfyn uchaf y mandad ar gyfer dal cronfa sengl o 10% – lle roedd yn dal 10.3% o gronfa eiddo prydles hir – rhoddwyd diweddariad gan Bennaeth Cyllid, Addysg ac Adroddiadau Ariannol yn cadarnhau bod y terfyn uchaf am ddaliad unigol wedi cynyddu o 10% i 15%.

1 CHAIRMAN'S REMARKS

The Chairman extended a welcome to David Francis, the Pension Board Employer Representative, to his first meeting of the RCT Pension Board.

2 DECLARATION OF INTEREST/CONFLICTS/CONFIDENTIALITY

There were no declarations of personal interests/conflicts in matters pertaining to the agenda and the confidential nature of proceedings was noted.

3 MINUTES

AGREED to approve as an accurate record, the minutes of the meeting of the RCT Pension Board held on 9th February 2017 subject to it being noted that the date for completing the GMP Reconciliation exercise would need to be completed by 18th December 2018 not 2017 as stated in the Minutes.

Matters Arising

- Minute 59 - Cashflow Position– Members were advised that this would be brought to the next appropriate meeting following completion of the analysis;
- Minute 59 – Mandates for Individual Holding Limits – the information was circulated for the benefit of the Board;
- Minute 60 – Invesco's Performance- The Board was advised that this item would be considered later in the agenda;

- Minute 61 – WDA Closed Liabilities - It was confirmed that the issue has been concluded and Welsh Government have accepted their new rates following the completion of the Valuation;
- Minute 63 – Member Data – It was confirmed that the time taken to identify deceased members of the fund to avoid overpayments has improved however, there were no further updates/trends to report from the completed survey and toolkit as yet; and,
- Minute 64 – GMP Reconciliation – It was confirmed that a GMP Reconciliation Progress Summary would be provided at the next meeting.

4 INVESTMENT & ADMINISTRATION ADVISORY PANEL

The Board was provided with an update in respect of the minutes of the meeting of the RCT Pension Fund Investment and Administration Advisory Panel held on 10th March 2017.

Following consideration of the report it was **RESOLVED**:

1. To note the minutes of the meeting of the RCT Pension Fund Investment and Administration Advisory Panel held on 10th March 2017;
2. That a further breakdown of the percentage within each heading within the table highlighting the quarter performance figures for all fund managers is provided at the next meeting of the Pension Board;
3. That the total return delivered by Newton's portfolio for the next quarter to March 2017 is circulated to the Board members following the meeting;
4. That the RCT Pension Board Terms of Reference is reviewed to ensure the members' tenure provides continuity to the Board; and,
5. That the Board receives an update on Employer transfers/cessations at the next appropriate Board meeting.

5 RISK MONITORING

The Board was presented with an assessment of the risks associated with the RCT Pension Fund and the control measures in place.

The Board requested that consideration is given to the recent cyber attack being included in the Pension Fund risks. The Head of Pensions, Payroll and Payments confirmed that following clarification from the Council's ICT department the specific risk is covered by Rhondda Cynon Taf Council's risk register and the Information Management Board. The Pension Fund system and data security is maintained within the Council's own ICT infrastructure and subject to the relevant controls.

In respect of the CBRE breaching their mandate maximum limit for holding a single fund of 10% whereby they held 10.3% of a long lease property fund, an update was provided by the Head of Finance, Education and Financial Reporting who confirmed that the maximum limit for a single holding has been increased from 10% to 15%.

Following a request for clarification in respect of some of the control measures in place, the Board **AGREED** to note the information provided.

6 GOVERNANCE

It was confirmed that the following items had previously been circulated in relation to the annual review, any further comments from Board Members to be forwarded to the Head of Pensions, Payroll & Payments:-

- Pension Fund Administration Strategy 2017;
- Pension Fund Governance Policy Statement 2017;
- Pension Fund Communication Policy 2017;
- RCT Pension Fund Compliance Statement 2017; and
- The Funding Strategy Statement 2017 (provided to a previous meeting of the Board)

Investment Strategy Statement

The Head of Finance, Education & Financial Reporting stated that the Investment Strategy Statement had previously been circulated to the Investment & Advisory Panel on the 10th March 2017 for appropriate external review and consultation, then to the Pension Fund Committee on the 25th April 2017. It was further clarified that the statement has been published to the RCT website on 31st March.

Members of the Board were asked to form a view on the content of the Statement and it was **AGREED** to note the content subject to the following amendments/inclusions:-

1. That the word 'who' is to be inserted into the last paragraph on page 23;
2. That the date 'March 2016' (page 26, first paragraph) is to be updated;
3. That the word 'annually' is duplicated (page 31);
4. That the sentence on page 31/32 should be altered to read:-
'Although the pursuit of a financial return is our predominant concern, we may also take non financial considerations into account provided this would not involve significant risk of financial detriment to the scheme;' and,
5. That a copy of the voting template is circulated to members of the RCT Pension Board.

Members of the Board stated the importance of the All Wales investment pool Business Plan being subject to regular review.

It was agreed that further information to be supplied to the Board regarding S212 of the Local Government and Public Involvement in Health Act 2007 referred to at section 4.

7 VALUATION

Members of the RCT Pension Board were presented with the Actuarial Valuation as at 31 March 2017 and considered the key headings within the report. Following consideration of the report it was **AGREED** to note the content.

8 ALL WALES POOLING

Members of the RCT Pension Board were provided with a verbal update in respect of progress being made towards developing LGPS investment pooling arrangements on an all Wales basis (with the aid of an additional handout circulated at the meeting).

The Head of Pensions, Payroll and Payments provided details of progress made to date to include governance arrangements; procurement of the operator and timelines associated with the LGPS all Wales Investment Pool.

Members **AGREED** the importance of the Terms of Reference associated policy which serves to clarify the relationship of all parties within the All Wales Investment Pool.

9 KNOWLEDGE AND UNDERSTANDING FRAMEWORK

The Chairman reminded all Members of the RCT Pension Board of the importance of retaining handouts from their training sessions so they can be circulated for information.

It was **AGREED** to note the Knowledge and Skills Framework.

10 OTHER BUSINESS

The Head of Pensions, Payroll and Payments confirmed that the Annual Benefits Scheme is underway and on target for issue by the 31st August 2017.

It was requested that all future minutes of the RCT Pension Board are circulated in a timely manner to incorporate a list of Action Points.

In response to a query around the 'fee transparency' work being conducted by the Scheme Advisory Board, the Head of Pensions, Payroll and Payments confirmed that progress is being made with some Fund Managers actively participating in this voluntary disclosure.

It was requested that a Factsheet on the 85 Rule is circulated following the meeting.

It was **AGREED** that the next meeting of the RCT Pension Board would be held on Tuesday, 12th September 2017 in Block F, Clydach Vale.
